1. Question: Could an allowance be given for item B under the structural scope of work. At this point you can not determine how many areas that will be located that will need to be replaced. It would be very difficult to put together an accurate estimate with the limited information in item B.

Answer: The entire roof surface that will require "sounding" is approximately 17,000 sf. "Sound" all masonry roof surface above the masonry walls in the pool area.
