If after an Asbestos Abatement contractor certifies the area safe to work after any dirt disturbing asbestos removal work completed, we would assume respirators would not be required to be worn by workmen.

1. Answer: Change Asbestos Note on sheet P1 to read "THE DIRT IN THE CRAWL SPACE OF BUILDING 2611 IS CONTAMINATED WITH ASBESTOS DEBRIS. COMPLY WITH OSHA'S RESPIRATORY PROTECTION STANDARDS. SUBMIT WORK PROCEDURES FOR CRAWLSPACE ENTRY.
